King's fierce determination to overturn the status quo of racial relations antagonized FBI director J. Edgar Hoover. *The FBI and Martin Luther King, Jr.* follows Hoover's personal obsession to destroy the civil rights leader. In an unprecedented abuse of governmental power, Hoover led one of the most invasive surveillance operations in American history, desperately trying to mar King's image. The Picturesque and the Sublime Susan Glickman 2000 Winner of the Gabrielle Roy Prize in English and the Raymond Klibansky Prize, The Picturesque and the Sublime is a cultural history of two hundred years of nature writing in Canada, from eighteenth-century prospect poems to contemporary encounters with landscape. Arguing against the received wisdom (made popular by Northrop Frye and Margaret Atwood) that Canadian writers view nature as hostile, Susan Glickman places Canadian literature in the English and European traditions of the sublime and the picturesque. Glickman argues that early immigrants to Canada brought with them the expectation that nature would be grand, mysterious, awesome – even terrifying – and welcomed scenes that conformed to these notions of sublimity. She contends that to interpret their descriptions of nature as "negative," as so many critics have done, is a significant misunderstanding. Glickman provides close readings of several important works, including Susanna Moodie's "Enthusiasm," Charles G.D. Roberts's Ave, and Paulette Jiles's "Song to the Rising Sun," and explores the poems in the context of theories of nature and art. Instead of projecting backward from a modernist perspective, Glickman reads forward from the discovery of landscape as a legitimate artistic subject in seventeenth-century England and argues that picturesque modes of description, and a sublime aesthetic, have governed much of the representation of nature in this country. Susan Glickman is a poet living in Toronto. She is the author of Complicity, The Power to Move, Henry Moore's Sheep and Other Poems, and Hide and Seek.

Neo Delhi and the Politics of Postcolonial Urbanism Rohan Kalyan 2017-04-07 This book is augmented by an interactive website (neodelhi.net). During research trips to Delhi and Gurgaon between 2008 and 2015 the author produced a multi-media urban archive that includes full color photos, an essay film, ethnographic videos, field notes and more pertaining to the arguments and ideas presented in this book. The reader is encouraged to actively engage with the website alongside this text. This book challenges the prevailing metro-centric view of globalization. Kalyan employs methodological approaches from political economy, urban studies and visual culture to render a vivid portrait of changing urban life in India's largest conurbation. The book will be of interest to students and scholars of urban studies, postcolonial studies and inter-disciplinary studies.

Negotiated Memory Julie Rak 2005-02 The Doukhobors, Russian-speaking immigrants who arrived in Canada beginning in 1899, are known primarily to the Canadian public through the sensationalist images of them as nude protestors, anarchists, and religious fanatics - representations largely propagated by government commissions and the Canadian media. In Negotiating Memory, Julie Rak examines the ways in which autobiographical strategies have been employed by the Doukhobors themselves in order to retell and reclaim their own history. Drawing from oral interviews, court documents, government reports, prison diaries, and media accounts, Rak demonstrates how the Doukhobors employed both "classic" and alternative forms of autobiography to communicate their views about communal living, vegetarianism, activism, and spiritual life, as well as to pass on traditions to successive generations. Surveys of fiction, drama and poetry are complemented by chapters on Aboriginal writing, autobiography, literary criticism, writing by women and the emergence of urban writing. Areas of research that have expanded since the first edition include environmental concerns and questions of sexuality which are freshly explored across several different chapters. A substantial chapter on francophone writing is included. Authors such as Margaret Atwood, noted for her experiments in multiple literary genres, are given full consideration, as is the work of authors who have achieved major recognition, such as Alice Munro, recipient of the Nobel Prize for literature.

Bentonville Nathaniel Cheairs Hughes Jr. 2000-11-09 The battle of Bentonville, the only major Civil War battle fought in North Carolina, was the Confederacy's last attempt to stop the devastating march of William Tecumseh Sherman's army north through the Carolinas. Despite their numerical disadvantage, General Joseph E. Johnston's Confederate forces successfully ambushed one wing of Sherman's army on March 19, 1865 but were soon repulsed. For the Confederates, it was a heroic but futile effort to delay the inevitable: within a month, both Richmond and Raleigh had fallen, and Lee had surrendered.
